

RESOLUTION NO. 2023-XX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRENTWOOD AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE AN AGREEMENT AND NECESSARY DOCUMENTS WITH AXON ENTERPRISES, INC. IN THE AMOUNT OF \$1,820,470 PLUS FUNDING AUTHORIZATION OF \$150,000 FOR CONTINGENCIES, FOR A TOTAL NOT-TO-EXCEED FUNDING AUTHORIZATION AMOUNT OF \$1,970,470 OVER A FIVE-YEAR TERM; AND AMENDING THE FY 2023/24 OPERATING BUDGET

WHEREAS, on December 10, 2019 the City Council adopted Resolution 2019-137, authorizing the City Manager or designee to execute an agreement with Axon Enterprises for the purchase and installation of body-worn cameras, in-car video systems, electronic control devices, interview room video and audio equipment, digital evidence storage, and unmanned aerial vehicles in a not-to-exceed amount of \$250,000 per year for a five-year term; and

WHEREAS, on January 24, 2023 the City Council adopted Resolution 2019-137, which among other actions, increased the authorized amount for Axon services provided during the fiscal year from \$250,000 to \$304,795; and

WHEREAS, the Police Department has used Axon Enterprise hardware and software since 2019 and has been very satisfied with its products and services; and

WHEREAS, Axon is the leading company in the area of body-worn cameras, in-car video systems, Electronic Control Devices, interview room video and audio equipment, digital evidence storage and unmanned aerial vehicles; and

WHEREAS, Axon's technology provides many cost and time saving benefits to the Police Department; and

WHEREAS, the Contra Costa County District Attorney's Office works exclusively with Axon's Evidence.com, and almost all police agencies in the county use Axon's hardware and software products; and

WHEREAS, the cost of Axon services would be funded by the General Fund, and capped at \$364,094 per year for a five-year term, plus a contingency of \$150,000 which would allow for future growth and technological improvements; and

WHEREAS, Axon is the only company offering a single digital software storage system that fully integrates all of the necessary operational equipment for the Police Department; and

WHEREAS, the Police Department is utilizing Council/Administrative Policy, Purchasing Policy No. 10-7 Section 5.3 Sole Source/Non Competitive Negotiations in procuring the necessary equipment and services from Axon.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Brentwood does hereby authorize the City Manager or designee to execute an agreement and necessary documents with Axon Enterprises, Inc. in the amount of \$1,820,470 plus funding authorization of \$150,000 for contingencies, for a total not-to-exceed funding authorization amount of \$1,970,470 over a five-year term; and amends the FY 2023/24 General Fund Operating Budget in the amount of \$74,830.
