A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRENTWOOD ACCEPTING THE WORK PERFORMED BY MERCOZA FOR THE PAVEMENT MANAGEMENT PROGRAM 2023 (CONCRETE), CIP PROJECT NO. 336-31702; AND REQUESTING THE CITY CLERK TO FILE A NOTICE OF COMPLETION WITH THE COUNTY RECORDER.

WHEREAS, on September 27, 2022, by Resolution No. 2022-118, the City Council approved the allocation of Fiscal Year 2022/23 Transportation Development Act, Article 3 Pedestrian/Bicycle Project Funding from the Metropolitan Transportation Commission ("MTC") in the amount of \$100,000 for the Fairview Avenue sidewalk project. The Fairview Avenue sidewalk project was incorporated in the Pavement Management Program 2023 (Concrete) for cost saving purposes and in order to perform the work before the repaving of Fairview Avenue; and

WHEREAS, on May 9, 2023, by Resolution No. 2023-55, the City Council approved the contract documents, awarded the bid and authorized the City Manager or designee to execute a construction contract and necessary documents for the Pavement Management Program 2023 (Concrete), CIP Project No. 336-31702 ("Project"), with Mercoza ("Contractor"), as the lowest responsible and responsive bidder, in the amount of \$549,360.50, plus funding authorization for a 15% contingency of \$82,404.08, for a total funding authorization not to exceed amount of \$631,764.58; and

WHEREAS, on June 13, 2023, by Resolution No. 2023-80, the City Council adopted the 2023/24-2027/28 Capital Improvement Program (CIP), which included the Project; and

WHEREAS, the Project upgraded curb ramps to be ADA compliant; removed and replaced existing sidewalk, driveway approaches, curb and gutter; removed a tree; adjusted utilities to grade; and constructed sidewalk along the east side of Fairview Avenue, south of Sand Creek Road; and

WHEREAS, the Contractor completed all improvements on December 8, 2023, per the contract documents, and staff is recommending that the work performed by the Contractor be accepted and the Notice of Completion filed with the County Recorder.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Brentwood does hereby accept the work performed by Mercoza for the Pavement Management Program 2023 (Concrete), CIP Project No. 336-31702; and request the City Clerk to file a Notice of Completion with the County Recorder.
