

## CITY COUNCIL/SUCCESSOR AGENCY MINUTES

October 24, 2023, 7:00 p.m.

#### A. CALL TO ORDER & ROLL CALL

Mayor Bryant called the meeting to order at 7:00 p.m.

Roll Call found the following members present; Mendoza, Meyer, Pierson, Oerlemans, and Mayor Bryant.

#### **B. PLEDGE OF ALLEGIANCE**

Mayor Bryant led the Pledge of Allegiance.

## C. PUBLIC COMMENTS

Rod Flohr spoke regarding the Zoom platform and felt there were ways logins could be required so that remote public comment could be reinstated for the general public comment period.

Paul Jarvis spoke regarding oil drilling moratorium and stated support for rejecting any items that have an oil component used in the production.

Denise Duran thanked the Council for their response to the hate speech and reported on Chamber events.

# D. INFORMATIONAL REPORTS FROM COUNCIL MEMBERS, COMMITTEES, LIAISONS, AND STAFF

Council Member Mendoza reported on attendance at the CalCities Mayor and Council Member Roundtable, volunteered at and attended Oktoberfest event, the Unity Event at City Park, a CALE meeting, Latino Caucus Communication Subcommittee, a screening of a Million Miles Away, and a costume giveaway for field workers by Hijas DelCampo.

Council Member Pierson reported on attendance at the CalCities East Bay Division meeting, watched the Planning Commission meeting of September 19, 2023, attendance at the Brentwood Union School District Diversity Committee retreat, and reported on the PAL Board Tamalefest and a PAL booth at Hometown Halloween.

Council Member Oerlemans reported on attendance at the Farmers Market, Oktoberfest, Unity Rally, reported he watched the September 19, 2023, Planning Commission meeting. He reported on the PAL Tamalefest and attendance for the homecoming for an injured Brentwood Police Officer. He further recognized the work of Chief Herbert during the time following the incident where the officer was injured.

#### F. PUBLIC HEARINGS

F.1 Call for Review of the Planning Commission's decision to approve applications for a Vesting Tentative Subdivision Map and a Design Review with associated Mitigated Negative Declaration for the Hanson Lane single-family residential project.

Following the presentation of the staff report, the Mayor opened the Public Hearing.

Keven Fryer, Meritage Homes, Applicant, spoke in support of the project.

Javier Hurtado spoke regarding the project, and requested a masonry fence be installed and spoke regarding impacts to the existing neighbors.

Maria Sanchez requested additional park space, and traffic impacts and safety to the existing neighbors.

Rod Flohr spoke in support of the item being called for review.

Carolina Villaseca spoke in support of increasing the park space and spoke regarding impacts to the existing neighbors.

Rosa inquired about EV Access and requested clarification and requested additional park space.

Dave Sparling stated the vote at the Planning Commission was four in favor and one absent.

Sinziana Todor spoke regarding the need for additional park space that could be easily accessed by neighbors.

Danny Dohrmann spoke regarding the importance of parks for the youth in the neighborhood.

There being no one else wishing to speak, it was moved/seconded by Meyer/Pierson to close the public hearing. Motion carried unanimous with Council Members Meyer, Mendoza, Oerlemans, Pierson, and Mayor Bryant in favor.

Mayor Bryant called for a recess at 9:37 p.m. and the City Council reconvened at 10:02 p.m.

Staff Prepared revised Resolutions for the Council, and provided an overview prior to adoption of the Resolutions.
