

CITY COUNCIL/SUCCESSOR AGENCY MINUTES

April 9, 2024, 7:00 p.m.

A. CALL TO ORDER & ROLL CALL

Mayor Bryant called the meeting to order at 7:00 p.m.

The City Council, by motion, directed staff to:

- Paint speed limit on the pavement on Vineyards Parkway at locations deemed appropriate by the City traffic engineer (and potentially Vintage Place)
- Complete re-assessment of stop sign warrant to determine if any further conditions are met
- Install stop signs if warranted. If not, return to the Council with a report
- Reduce landscaping 24" in height or greater where needed at the discretion of City staff

- · Continue seeking grants for RRFB's
- As staff completes the tasks above, factor the existence of parks into work
- Be proactive on Vineyards amphitheater mitigations or compliance with traffic standards
