TITLE/RECOMMENDATION

Adopt a Resolution approving the purchase of one new 40,000 lb Equipment Trailer (Trail-Eze TE401) from Great Western Trailer in Fontana, CA; and authorizing the City Manager or designee to execute any necessary documents in an amount not to exceed \$90,225.

FISCAL IMPACT

The total cost of one new 40,000 lb Equipment Trailer (Trail-Eze TE401) to be purchased from Great Western Trailer is a not to exceed amount of \$90,225, which is included in the FY 2024/25 Wastewater Enterprise Fund Operating Budget.

BACKGROUND

City Council approval for the 40,000 lb Equipment Trailer was requested and received as part of the 2024/25 – 2025/26 Operating Budget adoption. The Equipment Trailer is necessary for staff to successfully implement the new sewer lateral repair program, also adopted as part of the 2024/25 – 2025/26 Operating Budget. The lateral repair program is designed to ensure that aging connections to the sewer system are repaired or replaced prior to failing, which helps prevent sewer overflows. Wastewater Collection staff will utilize the Trailer to transport equipment to and from the repair locations throughout town. Additionally, the Trailer will also be used to respond to any after-hours sanitary sewer backup service calls as they arise.
