Additional points of consideration

• Economic Benefits:

- New Jobs, this business will employ between 20 and 30 people, year-round, in both full time and part time positions, providing summer job opportunities for school age youth.
- o Contribution to the tax base within the community.
- The revenue generated for the Landlord will provide funding, and incentive, to invest in the shopping center.
 - To this point, the Landlord has offered, in the event this project is approved, to stripe and seal the parking lot of the center, as a first step in improving the look and feel of the center as a whole.

Community Courtyard:

- It was never the intention for the Community Courtyard to be just an open space. The goal, through the process, was intended to develop that space into a place where people want to gather with others in the community and spend time. With that goal in mind, we are proposing the following;
 - The space is open to all within the community to use. We envision this as a place for community meetings, small gatherings for friends to share their morning coffee, a place where community groups can plan and host events, in a clean and safe environment.
 - The design of the Community Courtyard was of heavy consideration when designing the site, with pedestrian friendliness in mind, the design ensures that not only is it in a prominent position on the site, easily visible, but only a few short steps away for all to gain access.
 - Additional seating options, such as benches, will be provided to give the community a place to sit, relax, and enjoy the company of their neighbors. The style and types of seating to be provided will be durable, stylish and comfortable so as to provide the best experience possible for those who visit.
 - Enhanced Landscaping will be provided within the space. Planters with both well maintained shrubbery and flowering plant types will be provided to both break the space up, providing areas of relative privacy for those who wish to gather in smaller groups, in addition to a more open space for larger gatherings.
 - Shading will be provided with the inclusion of trees being proposed around the perimeter of the Courtyard along with the Trellis being provided, to ensure the comfort of the community year-round.

Architectural Design:

the surrounding area and to become a beacon for future development in the area. To that end,
additional features have been provided, such as a trellis over the Drive-Thru Lane, creating
