On November 12, 2014, City Council adopted Resolution 2014-170 approving an MOU between the City and the District regarding PADA's murals at the cost of \$10,463.64, amending the FY 2014/15 Operating Budget by increasing the Public Art Acquisition Fund by \$10,463.64 and authorizing the City Manager to execute the MOU and make minor technical revisions to it in consultation with the City Attorney; and

On October 27, 2015, City Council adopted Resolution 2015-161 approving a MOU between the City and the District regarding PADA's mosaic sculptures at the cost of \$16,728, amending the FY 2015/16 Operating Budget by increasing the Public Art Acquisition Fund by \$16,728 and authorizing the City Manager to execute the MOU and make minor technical revisions to it in consultation with the City Attorney; and

On November 15, 2016, City Council adopted Resolution 2016-156 approving a MOU between the City and the District regarding PADA's mixed media mural at the cost of \$11,892, amending the FY 2016/17 Operating Budget by increasing the Public Art Acquisition Fund by \$11,892 and authorizing the City Manager to execute the MOU and make minor technical revisions to it in consultation with the City Attorney; and

On November 14, 2017, City Council adopted Resolution 2017-145 approving a Memorandum of Understanding between the City and the District regarding the PADA mural at the cost of \$14,746, amending the FY 2017/18 Operating Budget by increasing the Public Art Acquisition Fund by \$14,746 and authorizing the City Manager or his designee to execute the Memorandum of Understanding and make minor technical revisions to it in consultation with the City Attorney; and

On November 13, 2018, City Council adopted Resolution 2018-147 approving a Memorandum of Understanding between the City and District regarding the PADA mural at the cost of \$9,434, amending the FY 2018/19 Operating Budget by increasing the Public Art Acquisition Fund by \$9,434 and authorizing the Director of Parks and Recreation to execute the Memorandum of Understanding and make minor technical revisions to it in consultation with the City Attorney; and

On January 28, 2020, City Council adopted Resolution 2020-08 approving a Memorandum of Understanding between the City and District regarding the PADA mural at the cost of \$4,819 amending the FY 2019/20 Operating Budget by increasing the Public Art Acquisition Fund by \$4,819 and authorizing the Director of Parks and Recreation to execute the Memorandum of Understanding and make minor technical revisions to it in consultation with the City Attorney; and

On February 9, 2021, City Council adopted 2021-21 Resolution approving a Memorandum of Understanding between the City and District regarding the PADA mural at the cost of \$12,299 amending the FY 2020/21 Operating Budget by increasing the Public Art Acquisition Fund by \$12,299 and authorizing the Director of Parks and Recreation to execute the Memorandum of Understanding and make minor technical revisions to it in consultation with the City Attorney; and

On February 8, 2022, City Council adopted 2022-21 Resolution approving a Memorandum of Understanding between the City and District regarding the PADA mural at the cost of \$10,426 amending the FY 2021/22 Operating Budget by increasing the Public Art Acquisition Fund by \$10,426 and authorizing the Director of Parks and Recreation to execute the Memorandum of Understanding and make minor technical revisions to it in consultation with the City Attorney; and

On April 11, 2023, City Council adopted 2023-43 Resolution approving a Memorandum of Understanding with the District regarding the PADA mural at the cost of \$3,513 amending the FY 2022/23 Operating Budget by increasing the Public Art Acquisition Fund by \$3,513 and authorizing the Director of Parks and Recreation or designee to execute the Memorandum of Understanding and make minor non-substantive revisions to it in consultation with the City Attorney

On January 23, 2024, City Council Adopted Resolution 2024-07 approving a Memorandum of Understanding between the City and District regarding the PADA project at a cost of \$20,272, amending FY 2023/24 or FY 2024/25 Operating Budget, depending on the timing of the PADA project, by increasing the Public Art Acquisition Fund by \$20,272, and authorizing the City Manager or designee to execute the MOU and make minor non-substantive revisions to it, in consultation with the City Attorney
