September 24, 2024, 7:00 p.m.

- 500 feet from K-12 (Private Educational Facilities, Public School Facilities) excluding three individualized areas. Map related to school radius for better understanding.
- Investigate signage related alcohol sales
- Residential separation of 100 feet
- Requires a CUP if open after 10 p.m. (explore a tiered system)
- Investigate potential definitions for bars and entertainment
